Monetary Policy Challenge national finalists announced

Congratulations to Christ's College and Christchurch Girls' High School finalists in the Reserve Bank's Monetary Policy Challenge. Teams from both schools will compete in the second round of competition next month.

Students from the 35 secondary schools that entered the competition had the opportunity to put themselves in the shoes of Reserve Bank economists and recommend what the Official Cash Rate could be. The competition is open to Year 12 and 13 secondary school students and can also contribute towards NCEA achievement standards.

At the National finals on 3 July six secondary school teams will give an oral presentation and compete for the title of Challenge winner.

UPDATE: Mana Ake – Stronger for Tomorrow



Feedback from a school survey in May has informed the criteria for prioritisation of communities of practice, school clusters, Kāhui Ako or geographic clusters for the next phase of the Mana Ake roll out.

As a result, Te Ara Tuhuru (North East Christchurch), Katote (Kaiapoi) and Totaranui (Papanui Redwood) clusters have agreed to participate in Mana Ake from Term 2.

Details about which schools are included in phase three (Term 4, October 2018) will be made available by the end of Term 2.

Enrolment schemes (zones)

Conversations have been taking place across the whole of our network about sustainable zones. We have been working closely with schools as they work to manage their rolls.

As you know enrolment schemes are implemented to prevent the risk of overcrowding and decisions are always made in the context of the wider network and involve consultation with neighbouring schools.

Establishing an enrolment scheme helps make effective and efficient use of schools capacity, and can give you more control over student numbers. Schemes ensure that space is available for local students and any student within the enrolment scheme home zone is entitled to attend the school.

Where you have surplus capacity, you may choose to accept additional students from outside your enrolment zone, but you need to ensure that there is enough room for all students to continue to learn comfortably.
