SPECIAL TEMPORARY ENROLMENT SCHEME: Mairehau School

This scheme commences on 29 May 2013.

Home zone

All students who live within the home zone **described below** (and *shown on the attached map*) shall be entitled to enrol at the school.

The Mairehau Primary School Zone is defined as follows:

The area within the below boundary, including both sides of boundary roads,

- Starting from the intersection of Cranford St and Berwick St in an anti-clockwise direction:
- East along Berwick St to Warrington St,
- East along Warrington St to intersection with Flockton St,
- North along Flockton St to Carrick St,
- Northeast along Carrick St to Aylesford St,
- Southeast along Aylesford St to Crosby St,
- Northeast along Crosby St to the end of the road (number 29 Crosby St),
- From the end of Crosby St, north west to Vangelis Lane,
- North along Vangelis Ln and Fernbrook Pl to Whitehall St,
- East along Whitehall St to Hills Rd,
- North along Hills Rd to Akaroa St.
- North east along Akaroa St to Briggs Rd,
- East along Briggs Rd to Marshland Rd,
- North along Marshland Rd to Queen Elizabeth II Drive (SH74),
- West along Queen Elizabeth II Drive (SH74) to Philpotts Rd,
- South along Philpotts Rd to Glenfield Cres,
- South west along Glenfield Cres to Roslyn Ave,
- South west along Roslyn Ave to Croziers Rd (including all addresses on Kew Place).
- North west along Croziers Rd to the end of the road, (number 60 Croziers Rd),
- From 60 Croziers Rd in a direct line south west to address 340 Cranford Street.
- South East from address 340 Cranford St to Berwick St.

Each year, applications for enrolment in the following year from in-zone students will be sought by a date which will be published in a daily or community newspaper circulating in the area served by the school. This will enable the board to assess the number of places which can be made available to students who live outside the home zone.

Former Glenmoor School students

Students enrolled at Glenmoor School on the date the Minister announced the closure of Glenmoor School may be enrolled at Mairehau School, regardless of whether they live within the enrolment scheme home zone described above. Enrolments made under this part of special temporary enrolment scheme must occur either during 2013

or for the start of 2014 school year. This provision will also apply to siblings (not yet at school) of eligible students.

Special programmes

Out of zone enrolments

Each year the board will determine the number of places which are likely to be available in the following year for the enrolment of students who live outside the home zone. The board will publish this information by notice in a daily or community newspaper circulating in the area served by the school. The notice will indicate how applications are to be made and will specify a date by which all applications must be received.

Applications for enrolment will be processed in the following order of priority:

- **First priority** This priority category is not applicable at this school because the school does not run a special programme approved by the Secretary.
- **Second priority** must be given to applicants who are siblings of current students.
- **Third priority** must be given to applicants who are siblings of former students.
- **Fourth priority** must be given to any applicant who is a child of a former student of the school.
- **Fifth priority** must be given to any applicant who is either a child of an employee of the board of the school or a child of a member of the board of the school.
- **Sixth priority** must be given to all other applicants.

If there are more applicants in the second, third, fourth, or fifth priority groups than there are places available, selection within the priority group will be by a ballot conducted in accordance with instructions issued by the Secretary under Section 11G(1) of the Education Act 1989. Parents will be informed of the date of any ballot by notice in a daily or community newspaper circulating in the area served by the school.

Applicants seeking second or third priority status may be required to give proof of a sibling relationship.
