Thank you for your feedback from our last newsletter where we added some tips regarding the Education Act Update. Many of you were especially interested in getting some more information on cohort entry. Boards must take all reasonable steps to discover and consider the views of community groups and those needing to be consulted with, including parents of current and prospective parents, staff, early childhood providers in the local community and a wider community group if your school wishes, such as other local primary schools and Kāhui Ako

Schools can fully adopt cohort entry after they've consulted and I have included information for schools looking to introduce cohort entry <a href="here">here</a>. NZSTA also continue to update and advise you through newsletters and their website, I have attached their cohort entry to school factsheet.

Cohort entry start dates are advertised on <u>our website</u>. If your school introduces cohort entry, the earliest a child can start under the cohort entry policy is term 1, 2018. Schools are required to give at least one term's notice to the community to ensure those who are affected by the change are given a chance to adapt.

Entries for the 2018 Prime Minister's Education Excellence Awards are now open. Winning programmes can have life changing results for learners and the financial benefits can help schools and early childhood education (ECE) me ngā kōhanga reo. The Awards recognise great collaboration, and help create brighter futures for our children and young people. ## Moderation 2017 Ongoing Resourcing Scheme and Extension, School High Health Needs Fund

This is to inform you that a decision has been made to retain the Ministry of Education's contribution towards teacher aides for students in the above schemes at the same level for the 2018 school year, as it was for the 2017 school year. Students whose funding has already been agreed for next year or who have an agreed review date, will not be affected by this decision. Students who received extraordinary funding in 2017 will return to their previous funding level for 2018.

We acknowledge that there may be a small number of students whose needs have changed, for example they are transitioning to a new school. Should you feel a student's needs may have changed please contact your key specialist or key contact to discuss. This includes students who may no longer require the level of contribution they currently receive. Please be aware that we will be running a moderation process in 2018 which may affect the funding for terms 3 and 4, 2018, if that is the decision of the moderation panel.

#### What you need to do:

To ensure your school's teacher aide funding remains accurate, we need to know if:

- An eligible student is absent from school for four weeks or more.
- There has been any change in circumstances associated with this funding (for example, if a teacher aide is away and cannot provide the agreed support or student illness).
- An eligible student has transferred to or from your school.

#### Please note:

Students with School High Health Needs funding expiring at the end of this year or at any time before the end of next year will only have funding reconfirmed to the point at which their verification expires.

Schools will still need to reapply for verification at the appropriate time.

#### **Assistive technology**

Assistive technology (AT) is specialised equipment and technology which students with additional learning needs use in class to increase or improve their ability to participate and learn.

To be able to apply for assistive technology a student will:

- be enrolled in compulsory education
- have a specific learning need and have difficulty following the curriculum using standard classroom technology
- be supported by one of our learning support services like:
  - Ongoing Resourcing Scheme
  - Speech-Language (Communication) Service
  - Severe Behaviour Initiative
  - Resource Teachers: Learning and Behaviour
  - Service for students with moderate sensory impairments and physical disabilities
  - School High Health Needs Fund
  - Special Education Grant (SEG)
