This is another step in restoring key infrastructure in the region and supporting the Ministry's commitment to its 'Learn to Swim' programme.

Finally, there's been a lot of talk in the media and online about the government's \$359 million Investing in Educational Success (IES) programme. Last week, the Ministry used web-chat for the first time to publicly discuss the policy. This generated a lot of interest and whilst there were many different views on IES, people did like the fact that we provided opportunities to meet and took the time to discuss the issues with them.

School Principal Roger Hornblow acknowleged key people involved in the new school build, including engineers and project managers, Ministry of Education officials and members of the community.

After the official opening the Prime Minister and Minister toured the school to see the Modern Learning Environment in action. When the greater Christchurch Education Renewal Programme is completed over 80% of teaching spaces in Christchurch will be modern learning environments, of course this will have a different look and feel as schools consider what is important to their school community.

### **Special Education**

Over the past two months, the Ministry has been engaging with the sector and community to consider future provision for the special schools network in greater Christchurch. This engagement follows an extensive period of consultation that has been occurring with the sector over the past 18 months.

The proposals for the future of the network focussed specifically on two issues:

1. The re-location and co-location of greater Christchurch's three special schools onto regular school sites, to provide equitable access whilst maintaining identity and independence.

2. The identification of existing and potential sites for satellite provision.

The Ministry has received submissions from the schools and their communities, as well as the disability sector and wider community and a report has now gone to the Minister. The engagement with the sector on these proposed changes has been a positive process. Both the sector and the Ministry are committed to working together to enhance inclusive practice and support the success of students with special education needs.

# Prime Minister's Education Excellence Awards

We are delighted to congratulate the two Christchurch winners of the inaugural Prime Minister's Education Excellence Awards. These Awards recognise and celebrate outstanding achievement in New Zealand education.

#### St Francis of Assisi

#### **Community Statement - St Francis of Assisi Catholic Primary School**

The future of schooling in the parish of Mairehau is a step closer following the Minister of Education's consideration of the proposal from the Bishop of Christchurch, Barry Jones for the cancellation of the integration agreement of both St Paul's and Our Lady of Fatima schools and the establishment and integration of a new state integrated school.

The Bishop's proposal was made following three rounds of community consultation, undertaken by the Bishop on a proposal to combine St Paul's School and Our Lady of Fatima School to form a new Catholic primary school on the current site of Our Lady of Fatima School on Innes Road.

On behalf of the Minister, the Ministry will now undertake its consultation, before a final decision is made on the Bishop's proposal.

The Ministry's consultation is with the boards of state and state-integrated schools whose rolls might be affected, and is expected to take about four weeks.

The Minister has asked that two options for the implementation timeframe be included as part of the consultation. Two possible dates for implementation of the change are the start of term 3, 2015 and the start of term 1, 2016. If the final decision is that the change takes place during 2015, schooling will need to operate from two sites while building work is completed.

After the Ministry's consultation, the Minister will then make a final decision about the proposed change and work would begin as soon as possible to implement it.

#### **Minor Works Programme**

To address this capital maintenance need, the Ministry has established a minor works team to take a proactive approach to capital repairs and maintenance at schools. Some schools may also be interested in trialling modern learning practices (prototyping). In some cases, this may be supported by minor alterations (up to \$15,000) to existing buildings to more closely resemble modern learning environments (MLE) ahead of entering the programme.

#### What works fall into the minor works programme?

The purpose of the minor works programme is to ensure that all schools remain operational, safe and secure prior to entering the Christchurch Schools Rebuild (CSR) programme. To qualify as a minor work, the work must meet the following criteria:

- Is the work required to address health and safety issues?
- Is the work required to address essential infrastructure issues?
- Will the work impact on what the school can do when they enter the programme?
- Is the building work minor in value (generally less than \$50k)?
- Is the building work required to support the school to better understand how they can teach in a MLE (i.e. alterations to provide a small MLE prototype teaching space – see below for more information on prototyping).

#### What is prototyping?

The Ministry is creating opportunities with schools to better understand Modern Learning Practices and Environments so that schools can make informed decisions about spaces for future learning and teaching.

This process referred to as prototyping, involves investigating, exploring and experiencing new learning and teaching environments. This can occur in existing spaces, however where necessary, the Ministry will support schools to make cost effective modifications to existing buildings to trial changes to teaching practice.

#### **Swimming Pool Repair Programme**

Two years ago, 23 school swimming pools damaged by the earthquakes were repaired. A further 15 pools have been identified as priorities and will be repaired in time for summer 2015.

The government is investing \$2 million on the swimming pool repair programme in greater Christchurch. The repair programme will be funded as part of the government's \$1.137 billion investment in education renewal in greater Christchurch.
